All the materials needed to apply for financial aid at Green Acres Camp for the 2012 camp year are available on our website ([www.greenacres.org](http://www.greenacres.org)). Please review the list of documents needed and the deadlines.

For your financial aid application to be complete, I must receive the following:

1. GAS Camp Financial Aid Request Form (attached) - **due 03/01/12.**
2. *Parents' Financial Statement* (PFS) from School & Student Services (SSS) (Green Acres' code is 3505). All parents/guardians must complete this form. If parents are divorced or separated, each parent/guardian must complete a separate form. The application is available at <http://sss.nais.org/parents/> . If you need a paper copy or require assistance completing the online process, please contact the Camp Office at [camp@greenacres.org](mailto:camp@greenacres.org)- **due to SSS by 03/01/12.**
3. A copy of final 2011 IRS Federal Tax Return, W-2's and 1099's from all parents or guardians - **due 03/01/12.**
4. IRS Form 4506-T from all parents/guardians. Send to Green Acres Camp (not the IRS). DO NOT send any money with this form. - **due 03/01/12.**

The deadline to return the GAS Camp request form is **March 1, 2012**. Complete your *Parents' Financial Statement* online with SSS by **March 1, 2012**. This allows sufficient time for SSS to process your application and have the report sent to Green Acres. All other forms must be received by Green Acres Camp **no later than March 1, 2012**.
